

Develop the concept in such a way that it facilitates the start of a project to cap I-280 and lead to a county-wide effort to reimagine the existing expressway and freeway rights-of-way.

The charter of the committee is to provide a conceptual view of what capping I-280 might look like, possible uses and a roadmap for Oops, we missed accomplishing a cap.

The deliverable, with a preliminary final publication for July 1st, 2017, will be a high-level feasibility study with recommendations on next steps.



- \$58-\$85k, high-quality, microhousing
- Stackable (up to 5 stories) and reconfigurable, like Legos

Valley of Vision

The current favored overall theme is "Valley of Vision." Whatever it is, it needs to convey the idea of the region's history being "transformational"—that is, how Santa Clara County fundamentally changed the United States. Largely, that is ultimately going to have to do with the rise of the high tech industry in the valley, the invention of the personal computer, the emergence of the Internet, and the foundation of entrepreneurial venture capital.

These things transformed the American and world economies and cultures by creating what we have today: the "knowledge economy" and "social media."

The National Association of City Transportation Officials (NACTO)



- Great cities generate traffic; traffic does not generate great cities.
- Technology has the power to help communities achieve their visions both for transportation and for land use, taking public space back from congestion, traffic and parking.
- Planning should begin with a vision for the future city and put resources into solving for the best methods for providing mobility in low, medium, and high density corridors and environments, from a public investment and a total investment perspective.

Car Ownership Costs (Money + Time) = High



Car Ownership Costs = High

\$8,558 / Year, USA = Depreciation @ 44% / Fuel @ 15% / Finance + Fees @ 14% / Insurance @ 14% / Maintenance + Repair @ 9%

Commuting Time = Significant

4.3 Hours per Week per Worker, Average (13% of Work Week, USA)

Urban Auto Commuting Delays = Rising

42 Hours / Year / Urban Worker, USA (+2x in 30 Years), Equivalent to ~1.2 Extra Work Weeks / Year

Millennials = Driving Differently

Drivers License Usage Declining (Age 16-44) = @ 77% vs. 92% (1982, USA)

Millennial Willingness to Car Share = @ ~50% (Asia-Pacific) / @ ~20% (North America)
